

OMCC TRACK BIKE RENTAL AGREEMENT



Terms and conditions

- The Track Bike is only available for current members only. It is only to be ridden by members of the OMCC.
- The OMCC Track Bike is available for hire at £50 per day. A **cash** deposit of £200 is required before picking up the Track Bike.
 - For commercial track days, allowance will be made for the logistics of travel to/from UK tracks. Dates and location for pick-up and drop-off will be agreed in advance with the Track Bike Manager.
 - Penalties may be charged for changing these dates and/or times at the last minute.
 - Cancellations of hire may also be subject to charges to cover the cost of any work/time required to prepare the bike for your use.
 - Within 72hrs of agreed pick-up date: £10 admin fee
- On collection of the Track Bike, an OMCC committee member will be present to hand over the keys, collect the deposit and note any current damage to the bike before the paperwork is signed.
- The Track Bike is just that – it is for the **Track Only**. No Track insurance comes with the Track Bike. If individuals require insurance then it is their own responsibility to ensure they have the necessary cover for the bike.
- Any damage to the Track Bike on return will be repaired, at the cheapest cost, by the OMCC. The money from the £200 deposit will be used to cover this. After all repairs have been completed then any remaining monies will be paid back to the member.
- Any mechanical malfunctions that occur with the Track Bike will be covered by OMCC, should any malfunction have ruined your track day, a full or partial refund **may** be considered.
- **Individuals ride the Track Bike at their own risk. OMCC takes no responsibility for any injuries occurred whilst on the Track Bike.**
- The committee reserves the right to refuse hire of the Track Bike.
- Upon the return of the Track Bike, an OMCC Committee Member will be present to check for any additional damage sustained during the rental period and to take note of any mechanical malfunctions that may have occurred.

OMCC Bike Rental agreement

I wish to use the OMCC Club track motorcycle (“track bike”) for the event shown below and enclose a cheque for £50 per day for the rental.

I understand that the OMCC Track Bike manager or appointed Committee member will be present to sign out/in the track bike, note any current damage to the track bike and to collect the **cash** deposit.

I confirm that whilst the track bike is in my care I will take all due care and attention not to damage the track bike in any way and should damage occur that OMCC will repair the bike using the cheapest way possible and that I agree to pay towards such repairs out of the deposit I have provided.

I understand that mechanical malfunctions that occur with the track bike will be covered by OMCC. I will ensure that the track bike is maintained (i.e. keep an eye on the oil level) during the rental period in such a way that potential mechanical malfunctions should be kept to a minimum.

I understand that only members of OMCC are permitted to ride the track bike at any time. I understand that only riders aged 18 years or above may ride the track bike.

I understand that no track insurance is included in the rental charges for the track bike and that it is my own responsibility to provide necessary cover should I wish to do so.

I confirm that the payment I have made to OMCC for the loan of the track bike is a rental charge only and does not include any payment for fuel, instruction or supervision or advice about bike setup or anything else.

I declare the following:

- I am competent and able to take part and that my eyesight (with lenses if worn) is adequate for riding the track bike at the event.
- That I do not suffer from any medical condition or disability which may make it unsafe for me to safely operate the track bike.
- That I hold the correct motorcycle license for the size and type of track bike being loaned to me. This license enables me to ride on the public roads in the UK or Europe or to participate in other racing events.
- That I will not ride the track bike whilst under the influence of alcohol or intoxicating drugs.
- I will satisfy myself (during sighting laps or otherwise) that the track bike is in a suitable condition for participating in the event and will raise any concerns to the Track Bike Manager, or appointed committee member immediately. By participating in the event I accept that the track bike has been presented in a satisfactory and safe condition.
